- Inability to attract a partner or debt financing;
- Inability to obtain the real value of their business when selling it to a strategic investor, or a significant reduction in the sale price;

To address the above and further problems many Ukrainian companies have chosen to set up corporate structures in foreign jurisdictions, such as Cyprus, Austria, the Netherlands or Great Britain.
